'ACTIV8' MEMBER CHALLENGE TERMS

The 'ACTIV8' Member Challenge begins Saturday 2nd May and ends Sunday 28th June 2026.

The Activ8 challenge is open to Kingston Active members 16 years+. Places are limited and subject to 'first in' policy. Members are required to book an initial Evolt body scan and sign this registration form.

Registrations open 7:00am on Thursday 23rd April until 8:30pm Friday 1st May 2026.

Criteria

Both the initial and final Evolt body scans are mandatory for participation in the challenge and must be completed in the specified times to determine a winner from each category.

Initial scans will commence from 7:30am Saturday 2nd May until 8:30pm Monday 4th May 2026.

Final scans will commence from 7:00am Friday 26th June until 2.00pm Sunday 28th June 2026.

If you are late or fail to turn up to your scan appointment, you may re-book in the next available time slot. If there are no available appointments within the specified times, you will be ineligible to win.

Bookings are made through the gym team at Waves. Only one initial and one final Evolt scan are included in the challenge.

Optional

30min personal training or technical check bookings will commence from Monday 25th May until Sunday 7th June. Bookings are made through the gym team at Waves, and provisions for bookings outside of these dates is at the discretion of the gym trainer, pending availability.

Prize Allocation

Prizes will be awarded for the greatest change in each category:

(1) LEAN BODY MASS

- ✓ Greatest increase in "Lean Body Mass" (difference between the initial scan and the final scan).

In case of a draw the following measurements, in given order, will be used to determine the result:

- greatest increase in "Skeletal Muscle Mass"
- highest "BWI Fitness Score"

(2) BODY FAT MASS

- ✓ Greatest decrease in "Body Fat Mass" (difference between the initial scan and the final scan).

In case of a draw the following measurements, in given order, will be used to determine the result:

- greatest decrease in "Visceral Fat Level"
- highest "Fitness Score"

All prize winners will be notified within two weeks of the challenge ending.
